May 18, 1926.

The Director submitted a Report dealing with work done since the adjournment of the Annual Meeting and the resolutions which should be adopted in order to carry on work on the various Restatements and on the Code of Criminal Procedure during the summer. The following is a summary:

Summary of Director's Report.

The only conference which has taken place since the adjournment. of the Annual Meeting is one in Torts, held at the Association of the Bar of the City of New York on the 13th, 14th and 15th of this month. This was what was designated as a "small conference" and was limited to Mr. Bohlen's special Advisers. The Topics dealt with were:

- (a) Privilege To Use Force To Regain Possession of Real Estate,
- (b) Privilege To Use Force to Obtain Chattels,
- (c) Privilege To Use Force In Family Discipline, etc.,
- (d) Privilege To Arrest With Or Without Warrant.

Those present besides your Director were Warren A. Seavey, Herbert F. Goodrich, Young B. Smith, and Edward S. Thurston. Edwin R. Keedy, Associate Reporter in Criminal Procedure, was present during part of the time when the Subject of Privilege To Arrest With Or Without Warrant was discussed. Mr. Bohlen had prepared for the meeting typewritten suggestions in regard to some of the sections in all of the Topics. Mr. Goodrich had prepared an elaborate Brief containing suggestions and tentative Sections on Privilege

To Arrest With Or Without Warrant. The conference, however, was in the nature of a preliminary discussion of the substantive law and a discussion of methods of approach and key-definitions such as the definitions of "Arrest" and "Warrant" in the Topic: "Privilege To Arrest With Or Without Warrant,. " At the conclusion of the conference I went over very carefully with those present the steps which in their opinion should be taken to insure the presentation to the Council of the draft of the law pertaining to the privileges discussed at the conference. It was agreed that the Reporter prepare, before he goes to Europe in June, a draft dealing with the Subjects discussed at the conference; that this draft shall be gone over in conference during July by Messrs. Seavey and Thurston, so that on the return of the Reporter from Europe on August 1, they will be able to submit to him the results of their revision of his draft. The Reporter will then prepare and send to the printer a draft which will be distributed to all his Advisers. It was the opinion of all present that such distribution can be made by the 16th of August. It was decided to request the Executive Committee to authorize the Director to call a conference in Torts at Northeast Harbor, Maine, the last days of August and the first days of September. It was the desire of all present that Judge Cardozo, Judge Burch, Judge Wheeler and Messrs. Hall and Roberts of the Council be present at this conference.

At the conclusion of the conference at Northeast Harbor it will be necessary to call another conference to go over a further draft of the same matter, the second conference taking place some time in October. It is hoped that at the conclusion of

this conference there can be sent to the Council a draft. which will complete all matters relating to Interference In Interests Of Personality.

RESOLVED: The sum of \$300 is transferred from account "Code of Criminal Procedure," item "Executive Committee Discretionary Fund" to a new item "Special Consultations between Reporters and Assistants" in the same account: the Director is authorized to draw warrants against the new item with the approval of the President.

Special Subject Considered.

The Director made a Statement in regard to the present and prospective financial condition of the Institute and the desirability of beginning work on the Restatement of the Law of Property at the earliest possible moment.

At the request of the Officers of the Institute he had prepared for the consideration of the meeting a draft of a Statement to the Carnegie Corporation setting forth the work which had been done in the past three years on the Restatement of the Law, the Subjects, or parts of Subjects, which could be completed in the next four or five years and the arrangement for the payment of the balance of the appropriation of the Carnegie Corporation which would enable the Institute to make the most effective use of the appropriation. The Draft was discussed and amended, and the meeting also prepared a formal letter to the Carnegie Corporation. At the conclusion of the discussion the following resolution was adopted:

Resolution No. 293. On motion,

RESOLVED: The President and Director are directed to transmit on our behalf to the Carnegie Corporation the following letter; the letter to be accompanied by the more detailed Statement considered and amended at this Meeting:

"To the Carnegie Corporation,

- "Gentlemen:
- "The Executive Committee of The American Law Institute beg to present to the Carnegie Corporation the following for consideration and to suggest as desirable a re-arrangement of the installments of the fund so generously granted by the Corporation.
 - "We find as our work goes on
 - "(I) that the wide and active interest in the Restatement of the Law has given an intensive character to the work which ought not to be checked and which if continued will result in covering the Subjects already undertaken for restatement in a shorter time and in concentrating the expenses for that work in that shorter time;
 - "(2) that before the Restatements now going on can have their final revision and be given to the public as official publications of the Institute certain other Subjects must also be brought to such a point that the very difficult matter of terminology in all the Restatements may be settled for all the principal related Subjects at the same time and each with reference to the others;
 - "(3) that this bringing forward of other Subjects instead of leaving them to follow will result in an earlier expenditure of the fund applicable.
- "We are now receiving on account of this fund \$110,000. annually in quarterly payments of \$27,500 each. We ask that beginning Januarv 1, 1927 the balance of the fund be paid over at "the rate of \$140,000 per annum in quarterly payments of \$35,000 each.
- "We submit herewith a Statement of the progress of our work on the Restatement of the Law and the reasons which lead us to believe that the arrangement suggested in regard to the pay-

ment of the balance of your appropriation would enable us to use your generous gift in the most effective manner.
